**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO,
INDIANA, AMENDING ORDINANCE NO 32-2012**

WHEREAS, on December 17, 2012, the Common Council of the City of Valparaiso, Indiana (“Common Council”), adopted Ordinance No. 32-2012; and

WHEREAS, Ordinance No. 32-2012 revised and amended the five (5) Councilmanic Districts existing within the City of Valparaiso, Indiana (“City”), based on Federal Census Data from the 2010 Census in accordance with Indiana law; and

WHEREAS, on December 20, 2012, Ordinance No. 32-2012 was recorded with the Porter County Recorder’s Office on Page 249; and

WHEREAS, a typographical error was recently discovered in Ordinance No. 32-2012 concerning Center Township Precinct 30 (“Precinct 30”); and

WHEREAS, as a result of the typographical error Ordinance No. 32-2012 did not specifically state that Precinct 30 was to be included within Councilmanic District Five (5); and

WHEREAS, the population figures for Precinct 30 were used to revise the Councilmanic Districts and the Council District Map attached to Ordinance No. 32-2012 as Exhibit “A” correctly depicts Precinct 30 as being located within Councilmanic District Five (5); and

WHEREAS, the Common Council is hereby desirous of adopting this Ordinance in order to amend Ordinance No. 32-2012 and correct the above-referenced typographical error to confirm the inclusion of Precinct 30 in Councilmanic District (5).

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Valparaiso, Indiana, that Ordinance No. 32-2012 and the Municipal Code of the City of Valparaiso are hereby revised and amended to read as follows:

11. COUNCILMANIC DISTRICTS

...

11.6 The Fifth Councilmanic District shall consist of Center Township election precincts 13, 22, 30, 34, 35 and Washington Township election precinct 3.


Any and all other provisions of Ordinance No. 32-2012 and Chapter Eleven of the Municipal Code of the City of Valparaiso shall remain in full force and effect.

If any portion of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other portion or provision of this Ordinance.

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency. It is provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects the ordinances or parts of ordinances are hereby ratified, re-established and confirmed.


This Ordinance shall be full force and effect from and after its adoption and the procedures required by law.




