## AN ORDINANCE AMENDING THE ZONING MAP REZONING LAND WITHIN THE CITY OF VALPARAISO LOCATED AT 2404 ROOSEVELT ROAD FROM UR URBAN RESIDENTIAL DISTRICT TO CG COMMERCIAL GENERAL DISTRICT
