ORDINANCE NO. 23-2009

ORDINANCE TO VACATING PLATTED EASEMENTS FOR SIDEWALKS AND PARKING ON LOTS A AND B IN GREENBRIAR ADDITION TO THE CITY OF VALPARAISO

WHEREAS, on or about July 9, 2009, William A. Ferngren of Ferngren Law Offices, filed a Petition to Vacate Platted Easements pertaining to sidewalks and parking lots on Lots A and B of Greenbriar Addition to the City of Valparaiso, on behalf of Centier Bank, Trustee of Land Trust # 1976; and

WHEREAS, the City of Valparaiso Plan Commission conducted a public hearing as to the *Petition to Vacate Platted Easements* consistent with the requirements of the Unified Development Ordinance Article 15 and finds the petition to be in order and that the proper notice was provided and recommended adoption of the proposed ordinance by a vote of 8-0 at the July 14, 2009 meeting; and

WHEREAS, the City of Valparaiso Board of Public Works and Safety considered the request at the July 23, 2009 meeting and recommended the adoption of the proposed ordinance and vacation of the platted private easements by a vote of 2-0-1 with one recusal; and.

WHEREAS, the Valparaiso City Council consistent with Indiana Code §36-7-3-12 finds the *Petition* to be in order and that appropriate notice was provided;

WHEREAS, on July 27, 2009 the Valparaiso City Council conducted a public hearing as to the *Petition to Vacate Platted Easements*; and

WHEREAS, the City Council did on $(lug_{10}, 2009)$ by a vote of 7-0 adopt the proposed ordinance with one condition.

NOW, THEREFORE, be it ordained by the common Council of the City of Valparaiso, Porter County, Indiana as follows:

1. The platted sidewalk and parking easements as shown on Lots A and B of the plat for Greenbriar Addition to the City of Valparaiso are hereby vacated subject to the following condition of approval:

a. That this approval be subject to the sale and proof of closing the subject property to Eastgate Investments II LLC and/or its assigns or affiliated entities. In the event of a failure of execution of said action, the above referenced vacation shall be null and void.


