ORDINANCE NO.: 21-2016

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, AMENDING ORDINANCE NO. 18-2016 ENTITLED "CITY OF VALPARAISO 2017 SALARY ORDINANCE"

WHEREAS, on August 22, 2016, the Common Council of the City of Valparaiso, Indiana ("Common Council"), adopted Ordinance No. 18-2016 entitled "City of Valparaiso 2017 Salary Ordinance"; and

WHEREAS, Ordinance No. 18-2016 established the salaries and other compensation to be paid to the employees/elected officials/members of boards and commissions of the City of Valparaiso, Indiana ("City") in 2017; and

WHEREAS, following the Common Council's adoption of Ordinance No. 18-2016, it was discovered that the Ordinance contained errors with regard to the compensation to be paid to the Valparaiso Police Department's civilian employees in 2017; and

WHEREAS, the Common Council is desirous of amending Ordinance No. 18-2016 in order to revise the compensation to be paid to the Valparaiso Police Department's civil employees in 2017.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, THAT ORDINANCE NO. 18-2016 SHALL BE AMENDED TO READ AS FOLLOWS:

Section 1. The following salaries set forth on the bottom of Page 9 of Ordinance No. 18-2016 shall be amended to state as follows:

BE IT ORDAINED THAT, if any portion of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other portion or provision of this Ordinance.

BE IT FURTHER ORDAINED THAT, all ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency. It is provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects the ordinances or parts of ordinances are hereby ratified, re-established and confirmed.

This Ordinance shall be full force and effect from and after its adoption and the procedures required by law.
