### **ORDINANCE #41, 2008**

AN ORDINANCE ANNEXING REAL ESTATE INTO THE FEE: \$17.00 CITY OF VALPARAISO, PORTER COUNTY, INDIANA KNOWN AS THE "KYRES ANNEXATION"

WHEREAS, Kyres Realty LLC are the owners of certain real estate located in Center Township requested at the November 10, 2008 City Council meeting that the real estate be annexed into the City of Valparaiso, Indiana, which real estate is more particularly described as follows:

WHEREAS, the Common Council of the City of Valparaiso, Indiana has heretofore considered and adopted a Fiscal Plan (Exhibit A) for such real estate as required by law; and

WHEREAS, the property sought to be annexed is situated outside the corporate boundaries of the municipal City of Valparaiso, Porter County, Indiana, and consists of approximately 0.59 acres of land; and

WHEREAS, the petitioners are the owner of 100% of the land sought to be annexed; and

WHEREAS, at least one eighth (1/8) of the aggregate external boundaries of the real estate sought for annexation coincides with the present boundaries of the City of Valparaiso, Indiana; and

WHEREAS, the City of Valparaiso Plan Commission favorably voted (8-0) to recommend approval of the proposed annexation at its October 27<sup>th</sup>, 2008 meeting, and favorably voted (8-0) to recommend approval of the request to rezone the land included in the annexation area from CM Moderately Intensity Commercial in the County to C-3 General Commercial District at its October 27<sup>th</sup>, 2008 meeting.

**NOW, THEREFORE, BE IT ORDAINED** by the Common Council of the City of Valparaiso, Porter County, Indiana as follows:

1. By and through the powers vested in the Common Council of the City of Valparaiso, Porter County, Indiana, the real estate identified in Exhibit A which has been attached hereto and made a part of this Ordinance should be and the same is hereby annexed into the municipal boundaries of the City of Valparaiso.
