ORDINANCE NO. 8-2007

AN ORDINANCE AMENDING ARTICLE XII OF THE ZONING ORDINANCE FOR THE CITY OF VALPARAISO.

WHEREAS, the City of Valparaiso has determined it is necessary to evaluate current fees for Plan Commission and Board of Zoning Appeals petitions and land use actions, and

WHEREAS, Planning and Building Department staff has evaluated current fee levels and researched fees in surrounding communities, and

WHEREAS, the general public was given an opportunity to comment on the proposed changes to the Article, and

WHEREAS, the Plan Commission voted to recommend the approval of proposed amendment changes by a vote of 7-0 on December 12, 2006.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Valparaiso as follows:

A. That Article XII, ADMINISTRATION, Section 1237, "Fees for Planning Actions and Petitions" is added to read as follows:
