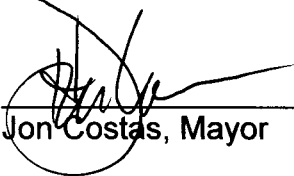

The Ordinance shall be in full force and effect immediately upon its adoption by the Common Council and approval by the Mayor.

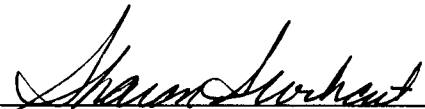

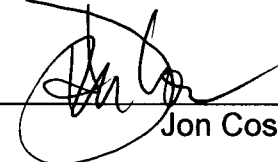
