

ORDINANCE #35, 2019

AN ORDINANCE APPROPRIATING FUNDS IN THE FIREFIGHTING FUND AND PROVIDING FOR PUBLICATION OF NOTICE

SECTION 1: BE IT ORDAINED, and the Common Council of the City of Valparaiso, Indiana, does hereby make the determination a need exists and that the following amount of money be and the same is hereby appropriated from the Firefighting Fund for the purpose and use here in after set forth, all for use during the current year of 2020, to-wit:

FIREFIGHTING FUND	
Personal Services	\$ 80,000
Supplies	\$ 5,000
Machinery & Equipment	\$ 100,000

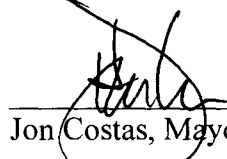
SECTION 2: The City Clerk-Treasurer is ordered to give ten (10) days notice by publication in the Vidette Times, a daily newspaper published and printed in the City of Valparaiso, Indiana, which notice shall inform taxpayers that they and each of them shall have the right to be heard thereon.

SECTION 3: Hearing for remonstrance and objections by taxpayers provided for in Section 2 hereof shall be and the same is hereby set for the December 9, 2019 meeting of the Common Council of the City of Valparaiso, Indiana, in the City Hall of said City.

SECTION 4: After such hearing held in accordance with such notices as herein provided, said Council shall by Ordinance confirm or disaffirm its said determination.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage in the manner provided by law.

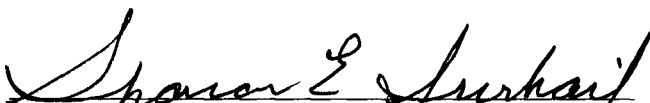
