RESOLUTION NO. 1,2011

A RESOLUTION OF THE BOARD OF PUBLIC WORKS AND SAFETY FOR THE CITY OF VALPARAISO, INDIANA, AUTHORIZING THE TRANSFER OF PROPERTY PURSUANT TO IND. CODE § 36-1-11-8

WHEREAS, the City of Valparaiso, Indiana, by and through its Board of Public Works and Safety, owns a 2000 Sterling LT7500 rear load garbage truck with vehicle identification number 2FZNALBB4YAA51476; and

WHEREAS, the City of Hobart, by and through its Board of Public Works and Safety, is desirous of purchasing the 2000 Sterling LT7500, from the City of Valparaiso, for the total purchase price of Five Thousand Dollars (\$5,000.00); and

WHEREAS, Ind. Code § 36-1-11-8 permits governmental entities to transfer or exchange property such as the 2000 Sterling LT7500 by adopting substantially identical resolutions setting forth the terms and conditions agreed upon by the entities; and

WHEREAS, pursuant to I.C. 36-1-11-8 on November 16, 2011, the City of Hobart Board of Public Works and Safety adopted Resolution No. 2011-11 entitled "A Resolution Authorizing the Purchase of a Used Garbage Truck from the City of Valparaiso, Indiana" which is attached to this Resolution as **Exhibit A**; and

WHEREAS, the City of Valparaiso, Indiana, by and through its Board of Public Works and Safety, is desirous of adopting a substantially identical resolution in order to finalize the terms of the sale of the 2000 Sterling LT7500 to the City of Hobart, Indiana.

NOW, THEREFORE, BE IT RESOLVED by the City of Valparaiso, Indiana, by and through its Board of Public Works and Safety, as follows:

1. That the City of Valparaiso, Indiana, by and through its Board of Public Works and Safety, agrees to sell the 2000 Sterling LT7500, Vehicle Identification No. 2FZNALBB4YAA51476, to the City of Hobart, Indiana, for the total purchase price of Five Thousand Dollars (\$5,000.00). The 2000 Sterling LT7500 is sold to the City of Hobart, Indiana, in "AS IS" condition with all faults. Both Cities hereby acknowledge that the 2000 Sterling LT7500 is in need of certain repairs and the City of Hobart accepts it with full knowledge of said repairs.
