NOW, THEREFORE, BE IT RESOLVED BY THE VALPARAISO BOARD OF PUBLIC WORKS AND SAFETY AS FOLLOWS:

SECTION 1. The Board of Works accepts the recommendation of Public Works and determines that the Property is worthless and may be disposed.

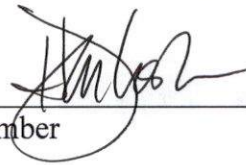

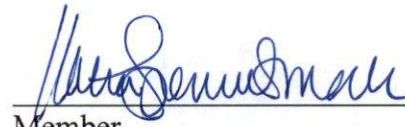
