

ORDINANCE #5, 2025

AN ORDINANCE APPROPRIATING FUNDS IN THE GENERAL BOARD OF WORKS, MVH RESTRICTED, LOCAL ROAD & STREET, WHEEL SURTAX, AND WHEEL TAX FUNDS AND PROVIDING FOR PUBLICATION OF NOTICE

WHEREAS, the City has taken affirmative steps over the years to properly repair and maintain its public streets to the extent funds are available.

WHEREAS, the City budgeted **\$5.1 million** in calendar year 2025 for use towards public street paving, repair, rehabilitation and maintenance.

WHEREAS, the City had identified further work that could be completed in calendar year 2025 if additional funds were available.

WHEREAS, the City, based on good financial management over the years, has additional funds available to meet this identified need.

WHEREAS, it is the intent of the City Council to appropriate the funds identified below for the purpose of funding public street paving, repair, rehabilitation and maintenance.

WHEREFORE, BE IT ORDAINED, and the Common Council of the City of Valparaiso, Indiana, does hereby make the determination a need exists and that the following amount of money be and the same is hereby appropriated from the following fund for the purpose and use here in after set forth, all for use during the current year of 2025, to-wit:

MVH Restricted – Paving (2203 015 364)	\$ 277,000.00
LR&S – Other Svcs & Charges Paving (2202 015 311)	\$ 321,666.00
Municipal Excise Surtax – Other Svcs & Charges (2249 015 311)	\$ 500,000.00
Municipal Wheel Tax – Other Svcs & Charges (2250 015 311)	\$ 20,000.00
Total	\$2,485,681.00

SECTION 1: Appropriations over and above those made during the budget process are allowed under Indiana Code 6-1.1-18-5 and as otherwise provided under Indiana law.

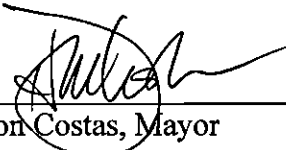
SECTION 2: The City Clerk-Treasurer is requested to provide notice, as outlined under Indiana Code 5-3-1, as to the meeting date and the opportunity of the public to participate in a Public Hearing. Such notice shall be published one time at least ten (10) days prior to the meeting in a Qualified Publication – as such term is defined under Indiana Code 5-3-1-0.7.

SECTION 3: The Public Hearing provided for in Section 3 shall be set for the **March 10th, 2025** meeting of the Common Council of the City of Valparaiso, at City Hall located at 166 Lincolnway.

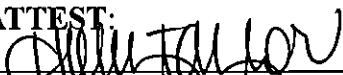
SECTION 4: After the Public Hearing is held in accordance with such notice as herein provided, the Council may approve the proposed appropriation.

PASSED by the Common Council of the City of Valparaiso, Indiana, by a 7-8 vote of all members present and voting, this 10th day of March, 2025.

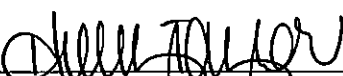

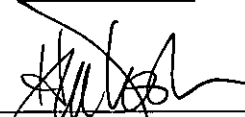
