

ORDINANCE NO. 12, 2025

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA AMENDING SECTIONS 72.01 OF THE VALPARAISO MUNICIPAL CODE CONCERNING METHOD OF PARKING

Whereas, the Valparaiso City Council ("Council") previously adopted Section 72.01 of the Valparaiso Municipal Code concerning the Method of Parking within the City of Valparaiso, Indiana ("City");

Whereas, the Council desires to make certain changes to Section 72.01 of the Valparaiso Municipal Code;

Now, Therefore, Be it and it is Hereby Ordained by the Common Council of the City of Valparaiso, Indiana, as follows:

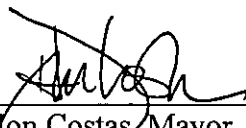
Section 1. That Section 72.01 of the Valparaiso Municipal Code of the City of Valparaiso, Indiana, shall be amended as follows: **See Exhibit A**

Section 2 *Conflicting Ordinances.* Any ordinance or provision of any ordinance of the City of Valparaiso, Indiana, in conflict with the provisions of this Ordinance is hereby repealed.

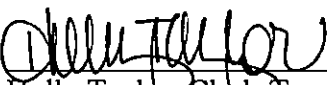
Section 3. *Severability.* The invalidity of any section, clause, sentence or provision of this Ordinance shall not affect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts.

Section 4. *Effective Date.* This Ordinance shall be in full force and effect after its passage, approval by the Mayor of the City of Valparaiso and publication as required by law.

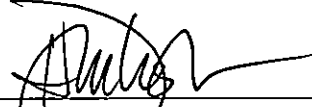

Exhibit A

§ 72.01 METHOD OF PARKING.

(A) No person shall stand or park a vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of lawful traffic movement and with the right-hand wheels of the vehicle within 12 inches of the curb or edge of the roadway, except as otherwise provided in this code. All vehicles parallel parking must follow the flow of traffic. No vehicles are permitted to park in the opposite direction of which traffic normally flows.

(B) Notwithstanding the above paragraph, no person shall stand or park a vehicle on the left hand side of a one-way street other than parallel with the edge of the roadway headed in the direction of lawful traffic movement and with the left-hand wheels of the vehicle within 12 inches of the curb or edge of the roadway.

(C) Upon those streets which have been signed or marked by the Board of Public Works and Safety for angle parking, no person shall park or stand a vehicle other than at the angle to the curb or edge of the roadway indicated by the signs or markings. No person shall back into an angle parking spot. All vehicles must pull forward into the angle parking stall with their rear license plate visible to the roadway.
