## **RESOLUTION NO. 8, 2025**

## A RESOLUTION OF THE CITY OF VALPARAISO, INDIANA COMMON COUNCIL APPROVING THE 2<sup>ND</sup> DISTRIBUTION OF OPIOID SETTLEMENT GRANT FUNDS

WHEREAS, as provided under Indiana Code § 4-6-15-4 and other applicable statutes, the City of Valparaiso has been the recipient of Opioid Settlement Funds relating to the settlement of various opioid litigation matters.

WHEREAS, as of the adoption of this Resolution, the City anticipates receiving a total distribution of Opioid Settlement Funds of approximately \$1,494,324.32 paid over the course of seventeen years (2022-2038).

WHEREAS, in April of 2022, both the City Council and Board of Public Works & Safety approved the expenditure of Opioid Settlement Funds for the hiring of a Community Care Recovery Coordinator by Prisoner and Community Together, Inc ("PACT"). That commitment automatically renews annually starting on December 31, 2025 absent termination by either party.

WHEREAS, in August of 2024, the City Council solicited applications from organizations seeking financial assistance for projects aimed to combat opioid addiction and its impact on our community.

WHEREAS, the City Council would like to once more solicit applications from organizations seeking financial assistance for projects aimed to combat opioid addiction and its impact on our community for a 2<sup>nd</sup> distribution of funds.

WHEREAS, after careful consideration, the Council has approved the identified applicants for funding contingent on the execution of a Grant Agreement.

**NOW, THEREFORE**, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, AS FOLLOWS:

SECTION 1 Attached as **Exhibit A** is a list of approved recipients of Opioid Settlement Funds.

SECTION 2 It is the direction of the City Council that the City Attorney prepare Grant Agreements for all recipients and circulate copies to all City Council members with the expectation that the Board of Public Works & Safety will approve all Grant Agreements.
