ORDINANCE NO. 4, 2011

AN ORDINANCE AMENDING THE ZONING MAP REZONING LAND WITHIN THE CITY OF VALPARAISO LOCATED AT 1000 KENTUCKY STREET AND 905 EVANS AVENUE FROM CN COMMERCIAL NEIGHBORHOOD DISTRICT TO NC60 NEIGHBORHOOD CONSERVATION 60 DISTRICT

WHEREAS, a petition was presented by John Hannon on behalf of the owner Jason Carter of Valparaiso to rezone land located at 1000 Kentucky Street and 905 Evans Avenue from CN COMMERCIAL NEIGHBORHOOD DISTRICT TO NC 60 NEIGHBORHOOD CONSERVATION 60 DISTRICT; and

WHEREAS, the Plan Commission duly advertised and held a public hearing on the proposed rezoning on December 14, 2010; and

WHEREAS, the general public was given an opportunity to comment on the proposed rezoning; and

WHEREAS, the Plan Commission voted to recommend approval of the rezoning on January 11, 2011 by a vote of 6-0.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Valparaiso as follows:

1) The following described real estate in the City of Valparaiso is rezoned to NC 60 NEIGHBORHOOD CONSERVATION 60 DISTRICT zoning classification to wit:
