#### **RESOLUTION NO. 2-2011**

## A PRELIMINARY RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, DESIGNATING CERTAIN PROPERTY LOCATED WITHIN THE CITY AS AN ECONOMIC REVITALIZATION AREA

WHEREAS, the Common Council of the City of Valparaiso, Indiana, is empowered pursuant to Ind. Code § 6-1.1-12.1 et seq. to establish economic revitalization areas ("ERA") within the City of Valparaiso, Indiana; and

WHEREAS, consistent with the provisions of Ind. Code § 6-1.1-12.1 et seq., the Common Council previously designated all land within the City zoned Campus ("CA") (excluding real estate owned by the Lutheran University Association), Light Industrial ("INL"), Heavy Industrial ("INH") and Business Park ("BP") an ERA by the adoption of Resolution No. 7-2010.

WHEREAS, in an effort to attract new quality jobs, retain existing quality jobs, broaden the tax base and foster the City of Valparaiso's economic vitality the Common Council is desirous of also designating certain property on Lincolnway as an ERA.

# NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF VALPARAISO THAT:

- 1. The Common Council finds and provides as follows:
  - A. Attached as **Exhibit A** to this Resolution is a map and general legal description of the designated ERA.
  - B. It is the finding of the Council that such area described in **Exhibit A** meets the definition of an ERA, as such term is defined under Indiana Code § 6-1.1-12.1-1(1).
  - C. Consistent with Indiana Code § 6-1.1-12.1-2.5(b), the City's Economic Development Director or his designee is directed to provide the appropriate notice to the County Assessor and to affected taxing units, and take other steps as required under the statute.
  - D. A Public Hearing on this matter is scheduled for January 24, 2011 at 7 p.m., or at such time as established by this Council.

This Resolution shall be in full force and effect from and after its passage and signing by the Mayor.

THENCE SOUTH 30'50'46" WEST, A DISTANCE OF 25.00 FEET TO A LINE WHICH IS 25 FEET NORTHEASTERLY OF AND PARALLEL WITH THE CENTERLINE OF THE EXISTING MAIN TRACK;
