

**RESOLUTION NO. 10-2013**

**A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO,  
INDIANA, ADOPTING THE 2030 ENVISION VALPARAISO COMPREHENSIVE  
PLAN**

**WHEREAS**, in May 2001, the Common Council of the City of Valparaiso, Indiana, adopted the City's Comprehensive Plan ("2001 Comprehensive Plan") in accordance with the requirements of Ind. Code § 36-7-4-500, *et seq.*; and

**WHEREAS**, the Common Council of the City of Valparaiso, Indiana, adopted amendments to the Comprehensive Plan in April 2003, May 2005 and August 2006; and

**WHEREAS**, in April of 2010, the City of Valparaiso, Indiana, by and through its Board of Public Works and Safety, contracted with Kendig Keast Collaborative in order to begin the process of drafting an amendment to replace the 2001 Comprehensive Plan; and

**WHEREAS**, in drafting the amendment to the 2001 Comprehensive Plan, the City of Valparaiso has met with stakeholders and convened public input sessions; and

**WHEREAS**, as a result of these efforts the City has drafted the *2030 Envision Valparaiso Comprehensive Plan* in order to amend and replace the 2001 Comprehensive Plan; and

**WHEREAS**, on April 30, 2013, the City of Valparaiso Plan Commission convened a properly advertised public hearing on the *2030 Envision Valparaiso Comprehensive Plan* in conformance with the requirements of Ind. Code §§ 36-7-4-511 and 36-7-4-508; and

**WHEREAS**, following the April 30<sup>th</sup> public hearing, the Valparaiso Plan Commission voted to approve the *2030 Envision Valparaiso Comprehensive Plan* and certified its decision to the Common Council with a favorable recommendation; and

**WHEREAS**, the Common Council has studied and reviewed the *2030 Envision Valparaiso Comprehensive Plan* and is desirous of adopting this Resolution in order to adopt the *2030 Comprehensive Plan* in order to amend and replace the 2001 Comprehensive Plan.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA THAT:**

The Common Council of the City of Valparaiso, Indiana, hereby approves and adopts the *2030 Envision Valparaiso Comprehensive Plan* so as to amend and replace the 2001 Comprehensive Plan in its entirety. A copy of the 2030 Envision Valparaiso Comprehensive Plan is attached hereto and incorporated by reference into this Resolution as **Exhibit "A"**. The Clerk-Treasurer of the City of Valparaiso, Indiana, is hereby directed to place one (1) copy of the 2030 Envision Valparaiso Comprehensive Plan on file with the Office of the Recorder of Porter County, Indiana in conformance with the requirements of Ind. Code § 36-7-4-509(b).
